Re: Emma Wilson Elementary School Transitional Kindergarten 1530 West 8th Avenue, Chico, California 95928

Scope- The work consists of constructing a new 3,160 SF single-story kindergarten building that will include two kindergarten classrooms, two toilet rooms, a workroom, a mechanical room, an extension of the security system, and the installation of entry door access control and Wi-Fi.

825 SF renovation of two existing restrooms, addition of one new all-gender restroom, installation of a new drinking fountain, and resurfacing of walls, flooring, and ceilings in the Building 500 entrance area.

Site improvements include grading and drainage, hardscape, landscaping and planting, irrigation, fence replacement, trash enclosure, accessible parking stall improvements, and other miscellaneous site enhancements.
