Reyes Construction is requesting bids in the areas described, but not limited to:

(Subcontractors): Pavement Grinding (Asphalt and Concrete), Sawcutting, Surveying, Quality Control, Trucking, Concrete Paving, CCTV Inspection of piping, Fencing and Minor Concrete

(Suppliers): Waterworks, Stormwater Pre-Treatment Unit, Ready-Mix Concrete, Aggregates and BMP Materials

#### Project Scope:

The project is to bring the Recycling Center in compliance with the Clean Water Act (CWA). Therefore, per the National Defense Authorization Act (NDAA), this is being classified as a repair project.

By bringing the Recycling Center in accordance with the existing stormwater permit, it will in turn be in compliance with the CWA.

General Permit for Stormwater, requires runoff sampling at the points of discharge. Sampling results routinely exceed regulatory limits for metals, Chemical Oxygen Demand, and Biological Oxygen Demand.

The Recycle Complex is approximately 5 acres. The primary facility onsite is a covered 16,200 SF sort, wash, and bale structure where workers are on a mechanized assembly line sorting products and materials.

There will be three efforts involved with improving the stormwater runoff.

- 1st Effort: Install concrete curb around site perimeter.

- 2nd Effort: Install storm drain inlets with filters and piping within the Recycle Center to capture the stormwater contained inside the recycle center from the curbing installed in the 1st effort.

- 3rd Effort: Installation of an active stormwater treatment system.
