
- 1. Visit website: https://ww2.arb.ca.gov/our-work/programs/truckstop-resources/road-zone
- 2. Scroll down to Regulations, Click Off-Road Diesel



3. Scroll down, Click on DOORS Login



- 4. Click "Create an account" and enter information and create an account, you will get an email with a password and a link to login.
- 5. Once logged in you will want to create a new fleet by clicking the green button "off-road Diesel Fleet"



- 6. Enter information and click "Save Data" at the bottom of the page
- 7. Click on DOORS Home at the top left of the page and enter vehicle information, if applicable.
- 8. Click on your company link under "Fleet/Company Name:"
- 9. Click on the green e-ROAR button at the top left of the screen
- 10. Click on Compliance Snapshot under item 1b to remove the red check mark
- 11. Click on e-ROAR again should have all green check marks
- 12. Scroll to the bottom and check the box "check Here" and then click Request PIN and proceed"
- 13. Will get notification with PIN in email
- 14. Scroll down to bottom of page and enter PIN click submit
- 15. Print Certificate to pdf and save to be submitted
