

NOTICE TO CONTRACTORS CALLING FOR BIDS

NOTICE IS HEREBY GIVEN that Escondido Union High School District of San Diego County, California, acting by and through its Governing Board, hereinafter referred to as the DISTRICT will receive up to, but not later than 2:00 PM, on the 19th day of February, 2025, sealed bids for the award of a contract for:

Escondido High School Kitchen Project

Description of Work: Work to include demolition of existing kitchen and create new kitchen based on DSA approved plans. Exclusions as listed in plans.

Estimated Project Cost: \$6,000,000 to \$7,000,000

Estimated Start Date: June 9, 2025

Completion of Work: Project shall be completed by June 9, 2026

Bids shall be received in the Purchasing Department at 302 North Midway Drive, Escondido, CA 92027, and shall be opened and publicly read aloud at the above-stated time and place.

A mandatory pre-bid job walk shall be held on January 9, 2025 at 9:00 AM at Escondido High School, located at 1535 N Broadway, Escondido, CA 92026. Any bid submitted by a Bidder who does not attend the mandatory pre-bid job walk shall be considered non-responsive.

Each bidder shall be a licensed contractor pursuant to the Business and Professions Code and shall be licensed in the following appropriate classification of contractor's license, for the work bid upon, and must maintain the license throughout the duration of the Contract: A General Engineering Contractor or B General Building Contractor.

Each bid shall conform and be responsive to the bid. Each bid submittal shall be accompanied by bid security in the form of cash, cashier's check, certified check, or bidder's bond executed by an admitted surety insurer, and made payable to the Escondido Union High School District, in the face amount of ten percent (10%) of the base bid amount.

Pursuant to Public Contract Code Section 10126 (c) (2) the District declares that the following method shall be used to determine the lowest, responsive bidder on the project: Total Base Bid for Project

This Project is a public work and subject to prevailing wage requirements per Labor Code §1720 et seq. The bidder/contractor and all subcontractors of every tier shall pay laborers performing any portion of the Project not less than the prevailing wage rate established for the labor provided. Pursuant to Labor Code §1771.4(a)(4), prevailing wage rate monitoring and enforcement shall be by the California Department of Industrial Relations

("DIR"). Each bidder must be registered with the DIR pursuant to Labor Code §1725.5 in order to be qualified to submit a bid or to perform work on this Project. Bids submitted by contractors not registered with the DIR will be rejected as non-responsive. All listed subcontractors in the bid also must be registered with the DIR at the time of bid opening. At all times during performance of the Project, the bidder/contractor and all subcontractors, of any tier, must be registered with the DIR. Bidders/contractors may register with the DIR online at <http://www.dir.ca.gov/Public-Works/PublicWorks.html>.

The District reserves the right to reject any or all bids, to accept or to reject any one or more items on a bid, or to waive any irregularities or informalities in the bids or in the bidding process.

No bidder may withdraw its bid for a period of sixty (60) days after the date set for the opening of bids.
